- Fuentes, touting himself as the grandson of immigrants, turned his back on the community by removing the funding for **Assembly Bill 1413** Dream Act provisions for 20,000 qualified California resident students who are presently, not citizens.
- Does Fuentes support a full throttle implementation of California's leading Climate Disruption mitigation **AB 32** or does he appear to, for the convenience of the moment? He holds himself accountable only to his Corporate Lobbyist legislation sponsors and authors who resist lawful compliance with **AB 32**.
- Fuentes, as Appropriations Chair, promoted **AB 2529**, that would have created a process in which any economic impact analysis (used by four key state agencies in creating new regulations) could bankroll an independent study - in effect, as critics say, to suspend implementation of **AB 32** - California's climate change mitigation.
- Fuentes promoted **AB 2531** which would expand CRA/LA's Kelo-Eminent Domain powers to the entire city. No parcel of land anywhere in the city would be safe. Wherever the CRA/LA keloes someone's property, every homeowner through the entire city pays the cost. CRA/LA takes all its properties off the incremental property tax rolls and that maneuver shifts the total burden for City services to the shoulders of the rest of us.
- Fuentes supported **SBX 3 18**, the bill passed last year which led to the release of violent felons and rapists based on the Non Revocable Parole (NRP) policy that California Department of Corrections and Rehabilitation Secretary Matthew Cate states "allows the CDCR to reserve active parole supervision for offenders who have been assessed as being high risk to re-offend, have a serious or violent commitment history, and sex offender."
- On all counts, Fuentes threatens our District and California with legislative procedural overrides, suspended climate change mitigation, anti-community legislation and burdens the taxpayer with bloated, unnecessary legal defense costs.

Recommendations on the November Propositions:

- Passage of Proposition 19 will spur Mexico to pass similar regulation and taxation measures that take control away from the drug cartels. Candidate Lindblad agrees with the Center for Immigrant Rights on the entire slate of State-wide Propositions, sharing the consensus of the Green Party of California on most of the Propositions:
- **Yes on 19** - Marijuana legalization. Allows regulation by local government.
- **Yes on 21** - Vehicle fee of \$18 for funding parks/wildlife.
- **No on 23** - Suspension of California's landmark climate disruption mitigation laws.
- **Yes on 24** - Cuts corporate tax breaks.
- **Yes on 25** - Lowers Legislative requirement to pass state budget to majority. Retains two-thirds vote requirement for taxes.
- **No on 26** - Increases to two-thirds from majority to adopt new state taxes, including those addressing adverse impacts on society or environment caused by the fee-payer's business.
- Though the Green Party of California withheld stating a position on the following Propositions, differing over incremental proportional representation (practiced by virtually all of the world's democracies) offered by Proposition 20. Candidate Lindblad and the Center for Immigrant Rights agree on empowering grassroots democracy by stopping Party, Lobbyist and Special interests from making power grabs of citizen and local governments rights:
- **Yes on 20** - Moves redistricting to a citizen commission from the Legislature.
- **No on 27** - Repeal of the citizen redistricting commission. Consolidates authority for redistricting with the Legislature.
- **Yes on 22** - Prohibits the state from raiding local government coffers.
